

Glowe Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.gloweconnective.com and Glowe Connective and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Glowe Connective include www.gloweconnective.com and Glowe. The Glowe website is a Small Business website. By using the Glowe website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Glowe may collect personally identifiable information, such as your:

- First and Last Name
- Email Address

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Glowe collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Glowe may also use your personally identifiable information to inform you of other products or services available from Glowe and its affiliates.

Sharing Information with Third Parties

Glowe does not sell, rent or lease its customer lists to third parties.

Glowe may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Glowe, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Use of Cookies

- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtain your informed consent;
